JCIRA Takes Action in Olympia

Día de Cabildeo de Inmigrantes y Refugiados

JCIRA Board Members joined 250 immigrant rights advocates from across Washington State for WAISN's (Washington Immigrant Rights Network) 6th Annual Immigrant & Refugee Advocacy Day on February 16th in Olympia. The WAISN coalition consists of over 400 immigrant and refugee rights organizations including JCIRA, as well as labor unions, grassroots groups, and faith communities, to support and build power for immigrants and refugees across Washington.

The level of organization of Advocacy Day was outstanding. JCIRA was able to meet in person with our District 24 legislative team including Representatives Mike Chapman and Steve Tharinger, and the legislative aid for Senator Kevin Van de Wege. Our mission was to convince the legislators to support two immigrant justice campaigns: Unemployment Insurance for Immigrant Undocumented Workers (HB1095 & SB5109) and Health Equity for Immigrants as a budget proviso.

Welcoming Library

The Welcoming Library is a collection of acclaimed children's illustrated books featuring stories of new immigrants and their families – in their home countries, or adjusting to life in the U.S. The goal of the collection is to raise awareness and build sensitivity for all ages through children's literature. Reading these stories can lead children to become comfortable talking about belonging, welcoming, assimilation, and the celebration of all families, languages and cultures.

The Port Townsend Library received a grant to acquire a Welcoming Library of 30 books and then contacted JCIRA to help distribute this visiting collection to schools, other libraries, after-school programs and other non-profit organizations in Jefferson County. Natalia Duran and Libby Palmer took the Welcoming Library to Chimacum Primary School on February 13, our first experience reading aloud to groups of young children. Michele Moriarty, Chimacum School Librarian, was the host and had arranged a full schedule of kindergarteners through 2nd graders coming and going in small groups.

Natalia started by introducing herself as an immigrant from Mexico, arriving in Port Townsend with her baby girl about 10 years ago. She stressed how much she loved living here. Libby then talked about her parents arriving in the U.S., one from Poland and the other from the Ukraine, and somehow meeting in New York City. Those personal introductions captured the kids' interest right at the beginning.

During the 3-hour session, a total of 8 different books were read aloud, with Natalia and Libby taking turns, so each group heard both readers. Some books were sad, even tragic in parts, dealing with families migrating due to war. Others stressed new arrivals in U.S.

engrossed.

Just before the end of the last session, a 2nd grader asked Natalia to read a small book completely in Spanish that she'd personally selected. Instead of reading it only to the girl, Natalia read the book aloud to the whole group. It was a funny book from the school collection and pretty soon, all of the kids - and the readers - were saying words aloud in Spanish, laughing together and saying goodbye in Spanish. It was a perfect ending to a great day.

The Welcoming Library's next session in Chimacum will involve 3rd and 4th graders, with perhaps more time given to discussion and questions, yet using the same collection of books.

DACA and the Dream Act

Senators Durbin and Graham again introduced the Dream Act on February 14, providing permanent protection from deportation and a pathway to citizenship for immigrants who were brought into the country by their parents when they were children. The Deferred Action for Childhood Arrivals (DACA) program was created in 2012 by President Obama. It provides temporary protection from deportation and authorization to work for those who qualify, but it does not provide a pathway to permanent residency or citizenship. The program has been controversial and the subject of partisan debate since its inception. It has been the subject of much court action aimed at shutting the program down. At present a lawsuit filed by nine states asking that DACA be declared illegal is pending with a decision expected this spring. There are now about 600,000 individuals covered by the DACA program. All of them live with an uncertain future, fearing that the program could end and deportation follow. The Dream Act would put an end to this unfair and unjust situation. JCIRA urges us to support passage of the Dream Act in any way possible.

Other Bills Introduced

A total of nineteen bills have been introduced in the House and three in the Senate. HR575 and HR614 seek to loosen the restrictions on temporary migrant workers in the fishing, seafood, and agricultural industries to address the serious worker shortages. This issue was the subject of the Farm Workforce Modernization Act which failed to

Proposals for Comprehensive Immigration Reform

The Biden Administration issued a "Blueprint for a Fair, Orderly and Humane Immigration System" in 2021 which remains on their agenda. This is available here.

The conservative CATO Institute published a white paper in 2020 titled "12 New Immigration Ideas for the 21st Century" available here.

Border Policies

Unfortunately the Biden Administration continues to enforce certain policies that prevent people from exercising their legal right to request asylum. For example, Public Health Title 42 is used to turn back many asylum seekers. The administration has announced plans to end the practice, but GOP Attorneys General have sought to intervene in the case to defend the policy. The Supreme Court ruled on February 16 that they will not consider this challenge, so the administration can stop using Title 42 to prevent entry. However, this will mean that many more people will be requesting asylum and so the workload on Border Patrol personnel will increase. This may exacerbate problems of asylum seekers not being treated humanely and with respect.
